APPRENTICE RATES

EFFECTIVE APRIL 1, 2020

With the exception of First Period (60%) Apprentices, contributions to Pension, Health & Welfare, Industry, Apprenticeship, IUPAT FTI-LMCF and the STAR Program are to be paid in full at rates established by the current Collective Bargaining Agreement. Payroll deductions for Administrative Dues Check-Off and Market Recovery Fund hourly contributions are paid by all Apprentices.

FIRST PERIOD (60%) APPRENTICES: Fringe benefits are limited to Health & Welfare, Vacation-Holiday Pay and Industry Fund; Pension, Apprenticeship, IUPAT FTI-LMCF and the STAR Program contributions are not due. 60% Apprentices are required to pay Administrative Dues Check-Off and Market Recovery Fund.
